In 2009, she became the first woman elected in a contested election as President to the Central New York Area Labor Federation, AFL-CIO.

Ann Marie's work experience in the hospitality industry combined with her education led her to be a successful local and statewide labor leader. Ann Marie has led numerous campaigns to advance the rights of all workers throughout New York State. She most recently organized the renovated Marriott Downtown Hotel Syracuse and was awarded the NAACP A. Philip Randolph Union Award for her work on social justice issues.

She has been lucky enough to be recognized by her fellow Unionists by receiving the Mother Jones Award from the HVALF.

Christina started out as an international flight attendant working for an airline contracted by the Department of Defense. After her brother encouraged her to take a test alongside him for the Iron Workers Union, she decided to trade in her wings for a spud wrench. For the past 5 years, Christina has made many strides to get where she is today

as one of a few female Structural Ironworkers. During her apprenticeship training, she was tasked to climb a 35-foot column in under 30 seconds. She trained herself until she could do it just as swiftly as the men and completed her climb in 12 seconds - a record time for women. Often the only female Ironworker on a site, Christina's work ethic consistently earns the respect of the men on her team and she was guickly promoted to Foreman on the job site for Gabriel Steel Erectors, Inc. Christina is dedicated to her union with the same passion, respect, and integrity she provides to her work. She attends her union's rallies and events, including apprenticeship school/union business, and strives to lend her support to her fellow union sisters throughout any obstacles incurred along the way.
